I. Introduction

The Lafayette Consolidated Government ('LCG') is pleased to issue this Request for Proposal ('RFP') for Professional Design and Engineering Services ("Project") related to complete street improvements along Willow Street ("Site") between Cora and Clifton Chenier Access Drive and Northgate Drive and Moss Street located in Lafayette, Louisiana.

This is a catalyst project from the Evangeline Corridor Initiative developed in partnership with the Evangeline Thruway Redevelopment Team (a 15-member commission of LCG Council). Professional Design and Engineering funds allocated for this Project total \$300,000.00.

The selected consultant/team ("Consultant Team") must be an expert in complete streets. Expertise in designing complete streets with urban design enhancements is requested. The primary focus of the project is engineering the improvements that will resolve for increased vehicular speed from the lack of traffic calming devices, fragmented sidewalks, faded markings, lack of bike lanes, lack of shaded pedestrian paths, and beautification of a well-trafficked road that connects two neighborhoods.

A. THE EVANGELINE CORRIDOR INITIATIVE

Willow Street bisects the Evangeline Corridor. An area of the city located along the Evangeline Thruway, which is an area expected to be greatly impacted by the proposed I-49 Connector.


The Evangeline Thruway will become an elevated interstate highway traveling through the heart of the city. A 5.5-mile portion of the Evangeline Thruway, from I-10 to US Highway 90 near Kaliste Saloom Road (near the Lafayette Regional Airport) that runs through the historic urban core of the city will become a segment of I-49, known as the I-49 Connector. This federal project, which is moving through the environmental process, is being carried out by the Louisiana Department of Transportation and Development (LaDOTD).

Locally, this change will help relieve traffic congestion along America's Energy Corridor and create a safer, faster hurricane evacuation route. It will also become part of an international network. When I-49 is complete it will connect New Orleans, Louisiana with Winnipeg, Canada.

This coming change is also an opportunity. For decades, neighborhoods in the Evangeline Corridor – areas closest to the I-49 Connector route – have been challenged by disinvestment, poverty, crime and low property values. Property along the couplet has been largely frozen in time caused by the uncertain future of the proposed I-49 Connector. Currently, the project has been narrowed to two (2) alternatives. The LaDOTD has acquired multiple properties over the time of the project development resulting in obsolescent building structures and crippling reinvestment. This is an opportunity to make our neighborhoods stronger: to preserve unique cultures, reverse blight, and promote economic investment.

In 2016, LCG received a federal TIGER grant for neighborhood planning. It created the Evangeline Corridor Initiative (ECI) to do planning work in neighborhoods impacted by the connector project.

The Evangeline Corridor Initiative began with neighbors, business owners and community leaders who shared their vision for a better corridor. With the help of planners and designers, engineers and architects, that community vision has become a plan of action – the ECI Planning Report. The Planning Report specifically discusses corridor revitalization strategies, planning elements and design concepts, infrastructure networks and streetscapes, district initiatives and catalyst projects, plan implementation and economic potential. As a result,



five district design manuals with a collective of 41 large-scale projects and area-wide strategies have been developed and have received over \$15 million in capital improvement project funding to date in LCG's budget. This proposed project carries forward the ECI Planning Report, specifically the Gateway District Design Manuals, outlining the strategies, interventions, and regulatory reforms that will facilitate a thriving economic environment in key sites along the corridor.

B. PROJECT BACKGROUND

The Willow Street corridor is a central travel route for residents of the numerous neighborhoods located along and on the periphery of its path. Government buildings (U.S. Post Office, municipal library, parks, and schools), retail (big box stores), other forms of commerce, and institutional facilities are co-located within the corridor. The primary demographic composition of the corridor neighborhoods is single family households with younger school-aged children. The area supports a relatively light employment density, with the average median gross income of \$29,000 as compared to \$58,850 for the city of Lafayette. This economic status is further reflected in the very high rate of families that do not own a car and are reliant on alternative forms of transportation. This point emphasizes the importance of creating transportation opportunities for walking, bicycling, and public transit. The future integrity of Willow Street's communities will depend on the corridor's comprehensive design and connections to other neighborhoods via alternative modes of transport.

The evaluation of the Willow Street corridor has allowed the design team to develop solutions that will mitigate the impacts of the I-49 connector and provide a more "complete street" solution resulting in safer pedestrian and bicycle use within the Willow Street corridor, while beautifying a key thoroughfare of north Lafayette. The proposed Willow Street design also reconnects communities by allowing for shorter crossing distances and enhanced safety and traffic calming measures at crosswalks.

LCG is requesting proposals for Professional Design and Engineering Services related to the following streetscape improvements along Willow Street between Cora Street and Clifton Chenier Access Drive (0.7 miles) and Northgate Drive and Moss Street (0.2 miles):

- Improving the existing right-of-way
- Improved street conditions
- Improved transit stops
- Multi-Use paths
- Green infrastructure improvements
- Pedestrian friendly design features
- Safer intersections and crosswalks

Design and engineering shall be based on Willow Street and Castille Avenue Street Improvements plan, discussed further in Section II A.

C. RFP SCHEDULE

II. Scope of Work

The consultant team shall build off of the Willow Street and Castille Avenue Street Improvements plan (Plan) and the Evangeline Corridor Initiative Gateway District Design Manual to develop a set of deliverables needed for design of the project.

A. EXISTING CONDITIONS ANALYSIS

- Collect survey data needed for design and development of construction drawings.
- Upon generation of survey data files, transmit to LCG for review. LCG will notify consultant team of errors or deficiencies identified.
- Upon completion of survey data review, consultant team shall lead a site walk with LCG and relevant stakeholders to identify issues and opportunities (informed by the Plan).
- Document the existing conditions through a series of maps, diagrams, site photographs, and narrative.
- Identify, research and summarize any planned overlapping capital improvement or transportation projects.
- Consider the land uses and zoning along the corridor.

B. CONCEPTUAL & SCHEMATIC DESIGN

The most unique feature of this Request For Proposal (RFP) is the Conceptual & Schematic Design section, where we require four (4) outreach meetings (3 stakeholder, 1 public) throughout the preliminary design phase of the project.

- STAKEHOLDER MEETING 1: Lead a work session with LCG, Willow Street residents, and relevant stakeholders to confirm design options for sidewalks, furniture zones, street trees, green infrastructure/landscaping, lighting, ADA facilities, crosswalks, lane configurations, intersection treatments, transit stops, signage, markings, bike lanes, and public art.
- As this project is not funded for construction at this point, recommend interim or phased interventions.
- Produce opinion of probable construction cost (i.e. construction cost estimate) using the Plan's conceptuels/typologies existing conditions analysis, and confirmed design options.
- Prepare a 15% plan submission (schematic design) with associated line-itemed opinion of probable construction cost (OPCC) suitable for initial review and comment by LCG.
- STAKEHOLDER MEETING 2: To review and confirm concept with key stakeholders before presenting it to the public.
- PUBLIC MEETING: After initial review and comment by LCG and stakeholders lead a public meeting.

C. CONSTRUCTION DOCUMENTS

- Prepare preliminary plans based on schematic design for Willow Street and incorporating comments received by LCG, stakeholders and the public
- Prepare a 60% plan submission (design development) with associated line-itemed OPCC.
- STAKEHOLDER MEETING 3: Lead a work session with LCG and relevant stakeholders to review construction document package and confirm design options in 60% plans.
- Prepare a 90% preliminary plan construction plans with an associated line-itemed OPCC.

- Prepare a 100% preliminary plan submission with final line-itemed OPCC. This new and/or relocated striping, signs, ADA compliance standards, green infrastructure, bicycle infrastructure, and landscape improvements.
- Construction documentation package shall generally follow the Plan’s conceptuall/typologies, confirmed design options, incorporation of comments received during various reviews.


III. Project Area and Community Background

Lafayette Parish consists of the incorporated city of Lafayette, the unincorporated areas of the parish, and several smaller municipalities. Both the city of Lafayette and the unincorporated areas of the parish are under the jurisdiction of LCG, while the smaller municipalities (Broussard, Carencro, Duson, Scott, and Youngsville) are self-governed. The city of Lafayette contains 126,674 persons with all of Lafayette Parish containing 243,692 persons (Census Bureau, American Fact Finder 2020). The I-49 Connector is completely bound inside the city of Lafayette.

Lafayette is generally viewed as a progressive and economically strong regional anchor community. While both the public and private sectors have worked hard to cultivate this view, stagnant and declining areas of Lafayette do exist. Of particular note is the I-49 Connector’s Urban Core Area (referred to hereinafter as “Urban Core Area”), defined as a 4.27 square mile (2,734 acres) area encompassing most of the oldest and original parts of the city. The Urban Core Area holds a lower socio-economic status than the comparison groups. The Urban Core Area population is 62.1% black or African American versus 23.8% parish-wide. It is considerably poorer with median household income at only 51.8% of the parish; and twice as many households below poverty, 32.7%, as compared to the parish sub-poverty value of 15.9%.

Transecting Lafayette are two major Interstates and a federal highway. Interstates 10 and 49 intersect in Lafayette Parish and have yielded significant economic development. US Highway 90 South (US90), an alternate route which connects Lafayette to New Orleans, bisects the Urban Core Area of Lafayette. This same highway also serves as a chosen route for the oilfield, transportation, and agriculture industries, and as an evacuation route for hurricanes.



Corridor Preservation and Management Alignment (hereinafter referred to as the ordinance of the Lafayette City-Parish constitutes an agreement between LaDOTD the request of the Federal Highway with work done as part of the Statement process.

The Action Plan describes three planning areas detailed in the Blue Book:

Level I – the right of way to be taken by the six-lane elevated Interstate structure, including interchanges.

- Level II – the next 500 feet outside of the right of way, and;
- Level III – those neighborhoods and areas outside of Level II that would be impacted.

Generally, responsibility for activities in Levels II and III is controlled by LCG. The Action Plan contains charts that delineate funding responsibility for a variety of tasks.

In part, the Action Plan committed LCG to the completion of several "supplementary" plans, specifically:

- An Economic Redevelopment Plan to mitigate negative implications while enhancing the corridor's positive impacts.
- A Land Bank Plan to manage real estate for redevelopment and facility construction.
- A Setback Plan to regulate land use near the actual transportation facilities.
- An Overlay Zoning Plan to regulate corridor land use, residential, and commercial activity.
- A Linear Green Space Concept Plan to utilize landscaping, pathways, park space, plazas and lighting in the corridor.
- The Housing Stock Preservation Plan to preserve existing dwellings in the corridor.
- The Housing Prototype Plan to build model replacement for displacements.
- The Tax Abatement Plan to utilize property tax policies to enhance other project activities.
- A Redevelopment Rights Plan to transfers land use rights between parcels.

For several years after the adoption of the Action Plan, attention turned to the completion of I-49 North, from Shreveport to the Arkansas state line. LCG and the LMPO continued planning during this time, particularly by the formation of three neighborhood-planning organizations within the Plan area. The work in these neighborhoods has been extensive—each has adopted its own land use plan within its boundaries, and has been implementing plans designed to improve quality of life and strengthen alternate modes of mobility. These neighborhoods are all included in the districts envisioned in the Action Plan and will continue to be active partners in the planning process.

The Action Plan further created an advisory committee called the Evangeline Thruway Redevelopment Team (hereinafter referred to as “ETRT”) to serve as the public body to lead the development of the Economic Redevelopment Plan. In 2010, after two years of work, the ETRT adopted the Tax Increment Financing District Committee Report (hereinafter referred to as the “ETRT Report”).

The ETRT Report suggested the formation of a committee to oversee and run a special taxing district that would research, plan, fund, and implement a variety of strategies, tools, and resources to mitigate negative impacts of the I-49 facilities.

Activities suggested by the ETRT report included:

- New infrastructure, including frontage roads, pedestrian/bike facilities, transit infrastructure, streetscapes, and intersection improvements.
- Further development of the area's bike trail including the Atakapas-Ishak Trail—a regional bike trail that begins in downtown Lafayette and provides connections to additional bike facilities throughout the corridor.
- A linear park system and other specialized recreation parks, as well as plazas and public art.
- The development and implementation of neighborhood plans inside the corridor.


The ETRT report also suggests planning and engineering studies that fulfill the “supplementary plans” required by the Action Plan (listed above). The ETRT Report serves as the jumping off point for the Plan. Its recommendations are general and generic in nature, but represents community support for proactive measures.

In 2012, LCG embarked upon a community-wide comprehensive planning process with consultant Wallace, Roberts, and Todd. Final adoption of the resulting plan occurred on June 10, 2014 by the Planning Commission and endorsed by City-Parish Council on July 1, 2014. View adopted plan, amendments, annual reports at <https://www.lafayettela.gov/DP/PlanningRezoning/PlanLafayette>. PlanLafayette calls for re-invigorated efforts

toward implementation of the mitigation techniques in the I-49 Corridor first discussed in the Blue Book. PlanLafayette also identifies the I-49 Corridor as a “target” area on the Future Land Use Map, where efforts will be made to encourage economic redevelopment by establishing new land use patterns that establish a more functional urban area, and by funding strategic infrastructure improvements that incentivize mixed-use and increased mobility. Thus, this Project will be used to implement related PlanLafayette activities in order to continue mitigating the effects of the construction of I-49 on Lafayette.

In 2016, LCG received a federal TIGER grant for neighborhood planning. It created the Evangeline Corridor Initiative, or ECI, to reduce the negative effects of the interstate highway and create plans for improvement.

The Evangeline Corridor Initiative began with neighbors, business owners and community leaders who shared their vision for a better corridor. With the help of planners and designers, engineers and architects, that community vision has become a plan of action – the ECI Planning Report. The planning report specifically discusses corridor revitalization strategies, planning elements and design concepts, infrastructure networks and streetscapes, district initiatives and catalyst projects, plan implementation and economic potential. As a result, over 41 large-scale projects and area-wide strategies have been developed with over \$15 million currently in capital improvement project funding. This proposed project carries forward the ECI Planning Report, specifically outlining the strategies, interventions, and regulatory reforms that will facilitate a thriving economic environment in key sites along the corridor.

In 2021, Lafayette Consolidated Government allocated funding towards the Willow Street and Castille Avenue Streetscape Improvements Plan (hereinafter referred to as the Plan) a project from the Gateway District Design manual in the ECI Planning report. During 2022, the consultant team studied the Willow Street corridor, met with residents, business owners, and area associations like the Greater Southwest Louisiana Black Chamber of Commerce and Oasis Community Coterie at the Martin Luther King Recreation Center. After reviewing area context for the inclusion of cultural fabric, traffic analysis for data overview, opportunities/constraints of the area as it exists today, and treatments/interventions to improve the quality of life for residents, the Plan was developed. C. STREET TYPOLOGIES

The street typologies and design interventions were developed after analyzing the existing conditions to establish safe and accessible multi-modal circulation throughout the Willow corridor. Utilizing the traffic analysis, GIS mapping, and onsite due diligence, recommendations and reconfigurations were made to the existing rights-of-way. As a result, several typologies were created to address these individual ROW sections along Willow Street.

Pedestrian and bike facilities were the main focus of this plan to create a safe passage through the defined site areas. Dedicated bike lanes with a minimum width of 5' were incorporated into the reconfiguration of the ROW along Willow Street and Castille Avenue. The lanes, acting as paved shoulders, are separated by marked lines, and high-visibility green paint is applied at intersections, crossings, and driveways to increase visibility for other modes of circulation (see Sec 3.2). In addition, disconnected sidewalks are reconnected and serve as multi-use paths that run parallel to major roads.

Intersections and crossing interventions were recommended to supplement the pedestrian and bike facilities. This solution would help enhance the safety of users through high visibility markings, Rectangular Rapid Flashing Beacons (RRFB), and dedicated crosswalks to easily access and control the flow of traffic at safe speeds while increasing motorized vehicular awareness.

Public transit stations were recognized through the site area and integrated into the recommended facilities to address. Key stations were identified and included safe layering of lanes with pedestrian and bicycle circulation. In addition, the stations identified have nearby marked crosswalks to help increase the safety of transit users and access throughout the area.

An additional layer of traffic calming was included in the design to increase safety across the site further. Currently, Willow Street acts as a "raceway" with wide 12' lanes and no existing devices to help mitigate abuse of speed regulations. Adding the design solutions mentioned above increases awareness and begins to address calming traffic issues. In addition, reduced speeds significantly decrease fatalities associated with pedestrian-vehicular accidents. Reinforcing this with road diet applications further enhances the effect of traffic slow-down with drivers paying more attention to closer vehicular proximities. The Road Diet design also increases the overall ROW area to incorporate pedestrian and bicycle facilities along the street.

Streetscape elements are recommended as an additional layer within these design typologies. The existing street conditions provide little shade, furnishings, or safety lighting. Street trees provide a myriad of benefits to streetscapes: increasing driver awareness, filtering and improving the quality of air produced by motor vehicles, reducing sub-canopy ambient temperatures, reduction of erosion through soil stabilization, absorbing stormwater runoff, providing a physical separation between vehicular and pedestrian traffic, and increasing beautification and

neighborhood identity. With the addition of pedestrian-scale amenities, the site safety and overall health of its users and environment would increase.

The final layer to supplement these typologies would be the addition of green infrastructure. With Louisiana receiving between 50 and 70 inches of precipitation each year (Source: ncics.org 2022), design interventions for the site should also consider sustainably mitigating this influx of rainfall. Recommended interventions include utilizing stormwater planters, bioswales, permeable pavers, and enhancing existing drainage infrastructure.

This statement must appear on the front of the certificate of insurance EXACTLY AS IT APPEARS HERE "The Lafayette City-Parish Consolidated Government, its officials, employees and volunteers must be named on all liability policies described above as additional insureds."

VI. Waiver of Insurance Requirements

Notwithstanding anything to the contrary contained herein, the Consolidated Government reserves the right at all times, in its discretion, to alter, amend, and/or waive insurance requirements set forth in this Section where the insurance carried and/or to be provided by the Contractor is deemed reasonable, sufficient and adequate to protect the interests of the Consolidated Government, provided that the Consolidated Government shall take no steps to impose more stringent and onerous insurance requirements on the Contractor than those contained herein.

VII. Waiver of Subrogation

Contractors must obtain a Waiver of Subrogation from all insurance carriers providing coverage under Sections I, II, III and IV in this Article for any and all claims which could be asserted against the Lafayette City-Parish Consolidated Government, its employees, agents, representatives, officers, directors, elected and appointed officials, and volunteers.

VIII. Professional Liability Insurance

Contractor shall provide Professional Liability Insurance in the amount of \$1,000,000.00 for the duration of this contract.

ARTICLE 4 - CANCELLATION OF INSURANCE

The contractor shall not cause any insurance policy to be cancelled or permit it to lapse and all insurance policies shall include a clause to the effect that the insurance policy or certificate shall not be subject to cancellation or to a reduction in the required limits of liability or amounts of insurance until notice has been mailed to the Owner stating the date when such cancellation or reduction shall be effective, which date shall not be less than thirty (30) days after such notice.

ARTICLE 5 – SUBCONTRACTORS

The Contractor shall perform with his own organization a reasonable portion of the work under this contract, as determined by the Engineer. As soon as practicable after the execution of the contract and any event at least seven (7) days prior to the time that any subcontractor shall commence any portion of the work, the contractor shall notify the engineer in writing of the names of the subcontractors proposed for the work and shall not employ any that the engineer, within a reasonable time, may object as incompetent or unfit.

Also, to encourage minority participation to the greatest extent possible, it is further required, of the contractor that any minority subcontractors, proposed for the work, be identified, as such, and the name and domicile of said minority subcontractor be provided.

The contractor agrees that he is fully responsible to the owner for the acts and omissions of his subcontractors and of persons either directly or indirectly employed by them, as he is for the acts of omissions of persons directly employed by him.

ARTICLE 6 – CANCELLATION OF CONTRACT

In the event of unsatisfactory services by the contractor or unforeseen or justifiable circumstances under this contract or convenience, the Lafayette City-Parish Consolidated Government will have the option to cancel the contract with sixty (60) days written notice to the contractor. In event of the termination of said contract, all obligations of either party under this contract shall cease.

ARTICLE 7 – SUBMISSION AND OPENING OF PROPOSALS

BIDS – All proposals shall be enclosed in a sealed package which will be marked with the name of the proposal being submitted, and shall be mailed or hand delivered to: Purchasing Division, Lafayette City-Parish Consolidated Government, PO Box 4017-C, 705 W. University Avenue, Lafayette, Louisiana 70502.

The “REQUEST FOR PROPOSALS” will establish the date and time of the proposal opening. Proposals will be received until the stated date and time. The timely delivery of the proposals solely rests with the bidder, and late arriving proposals will not be considered.

Sealed package shall contain one (1) marked original, five (5) marked exact copies, one (1) USB electronic exact copy and one (1) redacted copy omitting all Proprietary/Confidential information. Note: Vendor shall indicate on the original any Proprietary and Confidential Information. Proprietary and Confidential Information shall only be considered as information outlined in Article 15.

ARTICLE 8 – ASSIGNMENT

Neither party to the contract shall assign the contract or sublet it as a whole without written consent of the other, nor shall the Proposer assign any moneys due or coming due to him hereunder without the previous written consent of the Owner.

No assignment of this contract shall be valid unless it shall contain a provision that the funds to be paid to the assignee under the assignment are subject to a prior lien for services rendered or materials supplied for performance of the work called for under the contract in favor of all persons, firms or corporations rendering such services or supplying such materials.

ARTICLE 9 - OPTION TO RENEW

The contract shall be automatically renewed on the anniversary date of the execution of the contract according to the terms of the contract. All costs and fees shall be held for the duration of the contract unless modified by Amendment prior to the anniversary date of the execution of the contract.

Any modifications to the contract shall be submitted at least sixty (60) days prior to annual expiration date and mutually agreed upon in writing. Any changes to the contract shall be submitted in the form of an Amendment and made a part of the contract.

ARTICLE 10 - NON-APPROPRIATION OF FUNDS

The continuation of this contract into a new fiscal year is contingent upon the appropriation of funds to fulfill the requirements of the contract. If the Lafayette City-Parish Consolidated Government fails to appropriate sufficient monies to provide for payments under the contract, the obligation to make payment under the contract shall terminate on the last day of the fiscal year for which funds were appropriated.

ARTICLE 11 - BUDGETED FUNDS

Notwithstanding anything to the contrary in the Agreement, the parties agree that the maximum amount payable under the Agreement shall be that which is the amount budgeted by the Lafayette City-Parish Consolidated Government for said project. In the event the total amount of the contract is increased by reason of additional quantities or any other reason, so as to exceed the amount budgeted, the parties agree that the Lafayette City-Parish Consolidated Government shall not be liable for the amount of such increase until and unless said budget is amended as provided for the Lafayette City-Parish Consolidated Government Home Rule Charter to allow for such an increased amount.

ARTICLE 12 - DEFENSE AND INDEMNITY

The Proposer agrees and obligates itself to defend, indemnify, and hold forever harmless the Lafayette City-Parish Consolidated Government, its employees, agents, representatives, officers, directors, elected and appointed officials, and any and all other persons for whom they may be deemed liable and or answerable to the extent permitted by law, for and against any and all claims, demands, causes of action, rights of action, suits, judgments, or executions which may be asserted by any persons or parties arising out of or resulting from any act of or omission of the contractor, its employees, agents representatives, and servants pursuant to the authority granted to it under the terms of this agreement, including any and all claims arising from the sole negligence, liability, and or fault of contractor, and or the joint and or concurrent negligence, liability, and or fault of the contractor with any other persons or parties whomsoever.

Notwithstanding the aforesaid, nothing contained herein shall be deemed to limit the obligations of any insurance company providing coverage in accordance with the terms of this Agreement to defend, indemnify, and hold harmless

the Lafayette City-Parish Consolidated Government, its employees, agents, persons or parties whomsoever to the full extent of their insurance contract and or as required by law.

ARTICLE 13 - CONTRACTORS UNDERSTANDING

It is understood that the contract is solely between the Lafayette City Parish Consolidated Government and the contracting agency and at all times, the contracting agency shall operate and deemed to be an independent contractor. At all times, persons provided by the contracting agency to the Lafayette City-Parish Consolidated Government pursuant to the terms of this contract shall be deemed to be employees of the contracting agency, and shall not be considered to be employees of the Lafayette City-Parish Consolidated Government of the Lafayette City-Parish Consolidated Government.

ARTICLE 14 - PARTICIPATION BY DISADVANTAGED ENTERPRISE BUSINESSES

The Lafayette Consolidated Government strongly encourages the participation of DBE's (Disadvantaged Business Enterprise) in all contracts or procurements let by the Lafayette Consolidated Government for goods and services and labor and material. To that end, all contractors and suppliers are encouraged to utilize DBE's business enterprises in the purchase or sub-contracting of materials, supplies, services and labor and material in which disadvantaged businesses are available. Assistance in identifying said businesses may be obtained by calling 291-8410.

ARTICLE 15 – PROPRIETARY/CONFIDENTIAL INFORMATION

LCG understands that some of the information contained in the RFP response form, Vendor Checklist & Questionnaire, and other documents may contain proprietary or confidential information. In order to avoid providing this information in the case of a Public Information Request, the bidder shall prepare and provide a redacted copy of the response form and other documents. Please note that only information which is in the nature of legitimate trade secrets or non-published financial data may be deemed proprietary or confidential. Any material within a proposal identified as such must be clearly marked in the proposal and will be handled in accordance with the Louisiana Public Records Law and applicable rules and regulations. LCG cannot guarantee that any material so marked will be maintained in confidence if, upon LCG's independent evaluation, such material does not fall inside the scope of Louisiana's Public Records Law. To that end, bidders are strongly encouraged to include alongside any material designated as confidential a detailed explanation, with citations to Title 44 of Louisiana's Revised Statutes, the basis on which they believe LCG may be permitted to maintain the subject information in confidence. Any proposal marked as confidential or proprietary in its entirety may be rejected without further consideration or recourse.

ARTICLE 16 – COSTS OF PROPOSAL

LCG is not liable for any costs incurred by prospective proposers prior to issuance of or entering into a contract. Costs associated with developing the proposal, preparing for oral presentations, and any other expenses incurred by the proposer in responding to this RFP are entirely the responsibility of the proposer, and shall not be reimbursed in any manner by LCG.

LCG will not be liable for any errors in proposals. LCG reserves the right to make corrections or amendments due to errors identified in proposals by LCG or the proposer. LCG, at its option, has the right to request clarification or additional information from the proposers.

LCG reserves the right to enter into a Contract without further discussion of the proposal submitted based on the initial offer received. LCG reserves the right to contract for all or a partial list of services offered in the proposal.

The RFP and proposal of the selected proposer will become part of any contract initiated by LCG. In no event is a Proposer to submit its own standard contract terms and conditions as a response to this RFP. The Proposer should submit with its proposal any exceptions or exact contract deviations that it wishes to negotiate. Negotiations may begin with the announcement of the selected Proposer.

Proposers are responsible for determining that there will be no conflict or violation of the Ethics Code if their company is awarded the contract. Ethics issues are interpreted by the Louisiana Board of Ethics.

ARTICLE 17 – GOVERNING LAWS

All activities associated with this RFP process and/or contract shall be interpreted under Louisiana Law. All proposals and contracts submitted are subject to the provisions of the Laws of the State of Louisiana and LCG Code of Ordinances; Purchasing rules and regulations; standard terms and conditions, including specifications listed in this RFP.

ARTICLE 18 - DISPUTE RESOLUTION

The parties shall use their best efforts to resolve all disputes in an amicable fashion. Prior to filing suit by either party with respect to any claims, or disputes arising between the parties, the disputes shall be submitted first to non-binding mediation. The mediation shall be conducted in accordance with the Construction Industry Mediation Rules of the American Arbitration Association. If the parties cannot agree to a private mediator, then the mediator shall be selected by the American Arbitration Association, upon the filing of a demand for mediation.

If the dispute is not resolved by mediation within 60 days from the request for mediation, then either party may, but is not required to, institute legal proceedings. The parties agree that the 15th Judicial District in and for the Parish of Lafayette, State of Louisiana shall have the sole jurisdiction in any action brought under the contract, or related to this Project. Alternatively, by written agreement of Owner and Contractor, the parties may elect to have all disputes resolved by arbitration.

ARTICLE 19 – TRAVEL AND LIVING EXPENSES

- All travel shall be by the most practical and reasonable means.
- Air travel shall be by tourist class and by the most economical means possible. LCG shall reimburse air travel based on actual receipts to include reasonable baggage charges.
- LCG will reimburse actual rental car rates as documented by receipts and based on: when one consultant is on-site, one rental car classed as intermediate/standard/mid-size will be allowed, when more than one consultant is on-site, LCG will reimburse the cost of one intermediate/standard/mid-size car per every two consultants.
- Personal Car mileage, if any, will be reimbursed under the policy guidelines at the IRS allowable reimbursable rate, rounded down to the nearest whole cent. The current mileage rate is .67 per mile.
- Meal Per Diems are set on a day rate based on the most current Tier I allowance as published by the State of Louisiana Department of Administration at <http://www.doa.la.gov/Pages/osp/travel/travelpolicy.aspx>. The current day rate for Lafayette is \$59 per day. Meal reimbursements do require detailed receipts to certify that no alcohol purchases were made. Under no circumstances will LCG reimburse a vendor for alcohol purchases.
- LCG will reimburse actual hotel rates for a standard room as documented by detailed receipts. Such reimbursement is limited to the actual room rate and applicable taxes and fees if any.
- LCG will reimburse other actual expenses based on receipts for items such as parking and taxi services.
- Other expenses not discussed above but which are deemed reasonable and necessary to the travel purpose may be reimbursable. These expenses must be approved by LCG before incurred.

- LCG will not reimburse any additional percentages added to travel and living expenses beyond actual costs. This removes any previous agreed to percentages and any that may have been overlooked.
